There is a major challenge here – making sure that hospitals, clinics and surgeries all have proper arrangements for monitoring and learning from the clinical care they provide. THE GMC, STATEMENT FOLLOWING ANNOUNCEMENT FROM THE SECRETARY OF STATE, ANDREW LANSLEY, REGARDING REVALIDATION, JUNE 2010

Through a series of presentation, this practical one day conference chaired by **Dr Nick Lyons** *Medical Director and Clinical Lead for the Pathfinder Pilots* The NHS Revalidation Support Team focuses on strengthening Appraisals and Revalidation looking at the way ahead. The conference opens with a presentation on Medical Revalidation and will discuss how Revalidation will work, what doctors and employers will be required to do, how patients will be involved, how and when Revalidation will be introduced, and the way ahead.

Dr Ian Finlay *Senior Medical Officer* for the Scottish Government Health Directorate will discuss identifying and assessing sources of information, and assessment tools blueprinted against the four domains of the GMP framework.

The conference continues with a presentation from **Dr Nick Lyons** *Medical Director and Clinical Lead for the Pathfinder Pilots* The NHS Revalidation Support Team, who will discuss assessing the readiness for medical Revalidation in your organisation, findings from the preparing for Revalidation AQMAR project, and update on the Revalidation pathfinder pilot sites, learning form any concerns flagged up by the pilot sites, the early adopter programmes – 'going live' in 2011. **Dr Ian Starke**, *Medical Director for Revalidation*, The Royal College of Physicians London and Lead for the Mersey Appraisal Pilots will then update delegates on the lessons from the Revalidation Pilots.

The afternoon sessions will focus on tackling performance concerns and supporting clinicians in difficulty and will provide an update on tackling performance concerns and the responsible officer, what has been learnt so far from the responsible officer pilot sites and moving forward with tackling concerns.

In light of the recent announcement by Andrew Lansley that the government will press ahead immediately with the introduction of Responsible Officers, the conference concludes with a presentation from **Mr David Evans** *Medical Director* Northumbria Healthcare NHS Trust and *Trainer* The National Clinical Assessment Service who will discuss managing a proportionate response to a concern, ensuring concerns are acted on quickly, developing a fair and consistent approach to managing informal concerns and confirmed poor performance, enabling and supporting doctors to overcome performance issues and concerns through resolution, remedial and development action.
