For example, patients with cancer typically spend 65-80% of their last 6 months of life at home and adequate pain control is often hindered by poor access to effective timely analgesia. These patients often have multiple, rapidly changing symptoms requiring highly specialist management"*

This important national conference provides an essential update for current and aspiring non medical prescribers on prescribing at the end of life. It is widely recognized that pain and symptom control at the end of life is not always optimal, the development of non medical prescribing has a key role in improving pain and symptom control for patients at the end of life. The Care Quality Commission stated in July 2020 that **"prescribing by non-medical prescribers increased in 2019, with the most significant increase from pharmacist prescribing, which increased by 80% over the previous year. Nurse prescribing also increased by 32%."**
