Last year a new and updated Competency Framework to support healthcare professionals to prescribe effectively was published by the Royal Pharmaceutical Society. Through national updates, practical case studies and extended expert sessions, this conference focuses on demonstrating and improving nurse prescribing competence and practice – embedding the competency framework, and ten competency dimensions for all nurse prescribers.
